Any adult who is classified as a "Less than 40' player may enter the 30 FT. OPEN DIVISION. JUNIOR DIVISION entrants must be 18 years old or less for the entire 2009 calendar year. Juniors age nine or under for the entire 2009 calendar year, may observe the 20 foot foul line, if so desired, but will be mixed with the 30' junior players according to ringer %.

## **ENTRY DEADLINE: June 1, 2009**

Entry Fee is \$30.00 (additional \$30.00 for Adult 40 Ft. and Adult 30 Ft. Championship classes). Pay only \$30.00 now. Extra fees will be paid upon qualifying. Juniors Pitch for free. Scorekeeping fees are \$1.00 per game, per player- Pay them directly. All mentioned dollars are in U.S. funds. Make all checks payable to: "Erie Horseshoe Club", in U.S. funds. Maximum number of entrants is 376. Entry is based on first paid first served. Entries after the deadline will be on a waiting list.
